I'm reaching out to share with you updates to our protocols and new programming for this Saturday night to engage the people we support.

Masks & Staffing Updates

Through generous donations and purchases we now have at least one cloth mask for each of our direct support staff and the people they support. More are still needed. We are now requiring support staff to wear masks at all times when they are at work and away from their home, and we have updated our <u>protocols</u> to reflect this change.

We are also adjusting the schedules of our direct support professionals to minimize exposure to others and reduce the chance of spreading the virus. We know changes in staffing are difficult for all, but in this unprecedented time we are taking every possible action to keep the people we support and our staff safe. Thank you for your understanding and flexibility as we make these necessary, temporary changes.
