Jubilee Association of Maryland's Breaking Barriers Program	Children	Helps people with intellectual and developmental disabilities navigate the system to access benefits or support services that they may be eligible for.	Email the Community Navigator at bb@jubileemd.org. You can also call or text directly to 240-621-2750. If you are making a referral, it's best if you share the person's contact info with the Community Navigator so that staff can contact and follow up with the person directly.	Montgomery County	Yes
Autism Waiver Program		Family consultation, therapeutic integration, respite care, environmental accessibility adaptations, adult life planning and residential habilitation (depending on need).	Families should contact the Autism Waiver Registry at 866-417-3480 to be added to the waitlist to apply for the Autism Waiver when a vacancy occurs. The Registry is a list of individuals interested in Autism Waiver services. The waitlist currently takes about 8-9 years. Infants and Toddlers Program	Toddlers,	Provides evaluation for developmental concerns. Those found with developmental delays are provided comprehensive services. Child Find	Children, ages 3-5	Provides developmental screenings.	Call the referral intake line: 301-947-6080  Montgome County		Yes, though proof of residency in the county is required
My Turn Program	( 'hildran	Provides information and referral to services and supports that a family may be eligible for. Can provide funding for camps.	Call 240-777-1216. If no one answers, leave a message, in any language, with the parent's name, contact info and preferred language.	Montgomery County	Yes
Montgomery County Public Schools (MCPS) Special Education Services	Children enrolled in an MCPS school	Provides evaluation for special education services.	A parent can request an evaluation for special education by writing. An email or letter should be dated and directed to the principal or classroom teacher. Respite Coordination	Children and Adults	Respite provides a short-term break for unpaid, live-in, primary caregivers. Families may apply for and receive respite in their own home, or in an approved location (therapeutic program, summer camp or respite facility). Income and other restrictions apply. Montgomery County	Yes, though proof of residency in the county is required
Low Intensity Support Services	Adults	Applicants are selected through lottery, and provided up to \$2,000 for eligible supports and services for people with developmental disabiltiies.	A person completes an online form to enter the lottery, which is conducted twice a year. If the person's name is selected, they complete a longer application and provide documentation of their residency in Maryland and their disability. More information: https://health.maryland.gov/dda/Pages/liss.aspx	Maryland	Yes, though proof of residency in the state is required
Disability Rights Maryland (DRM)	Children and Adults	Legal services related to special education, healthcare, mental health, housing, transportation, voting, and access to services.	Contact the intake office at 410-727-6352 ext. 0 (ask for "intake"), Monday through Friday, between 9 AM and 5 PM to learn if DRM can assist you. Read the Advocacy Service Plan, to better understand who DRM can serve based on advocacy priorities.	Maryland	Yes
Division of Rehabilitation Services	Students (ages 14-20)	Pre-Employment Transition Services (Pre-ETS) are available to any student with an IEP, 504 plan, or documented disability. Vocational Rehabilitation (VR) services are available to eligible adults who may need supports and services to find and keep a job.	Complete the online referral form: https://survey.alchemer.com/s3/5391921/DORS-Online-Referral-for-Direct-Input-Into-AWARE	Maryland	Pre-ETS is available regardless of immigration status. VR services are available to people with work authorization or U.S. citizenship.
Independence Now	-	Provides information and referral, advocacy, peer support, independent living skills training, and transition support.
