More than **150** adults with disabilities trusted Jubilee every day for residential support services to live fully in the community.

**11** new people began receiving residential support services with Jubilee.

Assisted **119** people with Housing Support Services.

Celebrated Parkside Landing's grand re-opening where **14** people Jubilee supports now have their own apartments.

Hosted **293** special events and classes to create opportunities for community and friendship.

**94** people accessed disability resources and services with help from Jubilee's Breaking Barriers program.


